

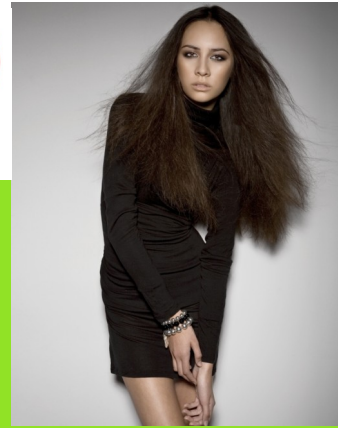

Highest Fundraiser Terms and Conditions of Entry

In addition to the terms and conditions of entry, entrants in the highest fundraiser category of the Model of the future competition are required to accept the terms and conditions listed here.

Entrants in the highest fundraiser category are required to provide proof of I.D. This may be by: Passport, Drivers Licence, Birth Certificate/Extract, Proof of age card.

To qualify for the major prize in the highest fundraiser category a minimum of \$1500 is required to be raised and returned to Rocky Bay prior to the first Semi final date*.

Entrants raising less than \$1500 are still permitted to enter this category of the competition and will not qualify for the major prize, but will qualify for incentive prizes.

Prizes will be awarded on completion of the competition, and incentive prizes are not accumulative.

If for any reason the highest fundraiser component of this competition is not capable of running as planned the organisation reserves the right to terminate the Highest Fundraiser category. These conditions include:

a) less than 10 entrants at the 7th May 2010.

b) a cumulative figure raised of less than \$15,000 between entrants in this category prior to the first semi final date

c) unauthorised intervention, tampering, fraud, technical failures or any causes beyond the control of Rocky Bay, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this promotion

Rocky Bay reserves the right in its sole discretion to:

a) disqualify any individual who tampers with the entry process

b) take any action that may be available

c) terminate or suspend the major prize category of the highest fundraiser aspect of the competition, subject to any direction given under state regulation.

In the case where receiving less than 10 entrants or a cumulative figure raised of less than \$15,000 between entrants in this category prior to the first semi final date, all entrants will still qualify for the incentive prize.
